The fire damper consists of housing in galvanized sheet steel and damper blade in non-combustible materials, electrical spring return actuator, limit switches and thermal tripping device. Size, W × H, 200×200 mm to 1500×800 mm. Activation is with a heat and/or smoke detector. The damper must be connected to the monitoring system. Function tests shall be performed at least once every 48 hours.

Fire protection system with fire damper WK45 connected to monitoring system designed to prevent fire and smoke spread in the ventilation system, which breaks through fire separating walls and floors.
