Lindab's work:

Lindab products and solutions should be the customer's first choice in terms of both quality and environment. We want to protect and preserve our planet and take our responsibility towards coming generations seriously. Lindab comply with, and when possible exceed, requirements from applicable legislation, regulations, codes of practice and other quality and environmental requirements. To secure compliance with REACH and SCIP part of Waste Framework Directive (WFD) suppliers of articles are assessed and asked to share information about Substances of Very High Concern (SVHC).

(Pre-) registration:

Importers are obliged to register substances they import in quantities over 1 ton per year. The registration requirement applies to substances on their own, in preparations and in articles under special conditions (intentional release). After a careful assessment of the substances imported into the EU by Lindab, none of the substances require (pre-) registration.

Authorization List

Lindab monitors the Authorisation List ([Annex XIV of REACH](#)). We are aware of the obligation to apply for an authorisation for the possible use of a substance on the Authorisation List, and the additional obligations that apply.

Restriction List

Lindab monitors the Restriction List ([Annex XVII of REACH](#)) and primarily work to substitute identified substances on the Restriction List with a safer alternative. Secondary, Lindab ensures compliance with the conditions of the restrictions.

Safety Data Sheet

Lindab is aware of the obligations as a distributor to provide Safety Data Sheets (SDS). In the case of a hazardous substance or mixture we provide a SDS, or an extended safety data sheet backed up by exposure scenarios. We make sure that it is in the respective national language and includes information required by the national legislation.

Substance of Very High Concern

Products with a chemical composition containing Substances of Very High Concern (SVHC) above the specified limits as listed by the European Chemicals Agency (ECHA) under the provisions of Regulation (EC) No. 1907/2006 of the European Parliament and of the council concerning the Registration, Evaluation, Authorization, and Restriction of Chemicals (REACH) per the ECHA 20/12/2010 and previous updates are registered in the SCIP database according to Waste Framework Directive (WFD).

The status of the candidate list (SVHC) will continue to be monitored. As established under the Article 33 of REACH, Lindab will inform product recipients and consumers if any substance or preparations of an article contains more than 0.1% by weight per article of any substance that is added to the SVHC candidate list in the future. For articles containing substances of very high concern, we are aware of the duty to provide customers with sufficient information to allow the safe use of the article, including, as a minimum, the name of the dangerous substance.
